In the first 5 months of 2019 we have had speakers at the monthly meetings presenting information on, development of housing tract plans on the old La Subida School property, SB 946 'Safe Sidewalk Vending Act', a proposed wireless telecommunications facility upgrade at 1415 S. Ninth St., and planning for the East San Gabriel Valley Transportation Corridors.

In February, HHIA Board Members, at the invitation of Supervisor Janice Hahn, attended a Los Angeles County Board of Supervisors meeting to testify in opposition to the proposed expansion of Quemetco's Operations. This concluded with a unanimous vote by the five Supervisors to share with Sacramento their overwhelming opposition and along with this momentum has started a wave of opposition of Quemetco's current operations and future operations coming from the office of HH's Congressman Cisneros, Senator Archuleta, Majority Leader Calderon, supported by other members of Congress and State Senators.

Ahead of us is our participation in the Jim Davis Beautification Day (29 June 19) cleaning the parade route for the I Love America Parade (4 July 19). Stay involved and be a part of keeping the quality of life in Hacienda Heights foremost on your list of things to do.

# The Mini –Cell Towers Are Coming-Regulations Are Needed By Maury Edwards

The advent of 5G internet requires a significant increase in capacity. The use of mini-cell towers to accommodate this need is the most efficient and preferred method of achieving the added capacity. The need to regulate the proliferation of mini-cell towers is necessary control the numbers and location of these cell towers. These mini-towers will be located at lower height and closer proximity to homes, business and schools. There is a concern in regard to health hazards with those living and working in close to RF emissions.

The L.A. County Board of Supervisors is considering the hiring Cityscape Inc. to help write the wireless facility ordinances. Cityscape is a consulting firm that works with cell phone companies to help them identify needed cell phone coverage areas.

Supervisors Hahn's Office sponsored a meeting on March 27th with Dr. Lee and other community members with Department of Regional Planning (DPR) in regards to concerns about Cityscape Inc consultants having serious conflict of interest with regards to writing wireless facility ordinance (cell towers).

L.A. County DPR members in attendance were: Amy Bodek, Director; Bruce Durbin, Supervising Regional Planner; and Dean Edwards, Senior Regional Planning Assistant. They explained that Cityscape was selected as the consultant based on competitive bids with only two respondents; the other respondent was associated directly with the cell phone industry and deemed unsuitable. To find another consultant at this time will require 6-9 months and delay adoption of the ordinance for nearly a year. Any further delay in adopting an ordinance is not acceptable especially in unincorporated areas of L.A. County. Several cities have already adopted ordinances but the unincorporated areas (Hacienda Heights) remain unregulated. HHIA. Directors will be monitoring progress in adopting suitable regulations.

- California cities cannot ban vending in parks.
- Cities cannot determine where vendors can operate, unless there is a health, safety, or welfare concern.

#### **How To Report A Possible Property Violation**

The Los Angeles County Department of Public works expanded their 'The Works' mobile application to include reporting possible property violations. You can now report excessive vegetation, junk or trash; illegal parking; inoperable vehicle; occupied RVs; and improper signs or banners. Users can submit a detailed description of an issue and attach a related site photo. # Los Angeles County Supervisors Vote to Create Regulatory Program for Scooters And Fireworks Are Illegal in Hacienda Heights David Salcedo, Public Safety & Health Committee Chair

#### Los Angeles County Supervisors Vote to Create Regulatory Program for Scooters

The Board of Supervisors approved a motion by Supervisor Kathryn Barger directing county agencies to develop a regulatory framework for the safe commercial operation of e-scooters in the communities of unincorporated Los Angeles County. Supervisor Barger's motion directs the CEO, in collaboration with county departments and agencies, to develop a pilot program with regulations allowing for the safe operation and storage of shared e-scooters and bikes on County roadways.

The County Supervisors want a collaborative plan that allows operators to provide a viable transit option for residents while minimizing the potential for public nuisances, safety issues, and lawsuits ultimately paid by taxpayers.

The program will also include a consumer-focused website regarding safety and other information to set the stage for a safe, sustainable, and innovative approach to incorporating e-scooters and bicycles as a service to residents looking to bridge gaps in transit access.

Residents have raised concerns regarding sidewalks crowded with equipment, riders who create dangerous conditions on sidewalks, and the risks of injuries.

Advocates say the scooters are an environmentally clean solution to gaps in available transit.

We are asking for the community 's feedback and questions, HHIA will present your feedback and questions to our County Supervisor, Janice Hahn.

### FIREWORKS ARE ILLEGAL IN UNICORPORATED LA COUNTY

Possession or use of illegal fireworks can range from a fine of up to \$1000, to one year in county jail. Certain products like m-80's and m-100's are considered explosives and are a felony to possess with penalties as high as 16 months in state prison. Parents are also liable for any damage or injuries caused by their children using fireworks.

On May 18, 2019 at 2:00 p.m. Hsi Temple held a community meeting at the Hacienda Heights Community Center to discuss the proposed Hsi Lai Temple Monastery Retreat Center the meeting concluded at 5:00 p.m.

The purpose of the meeting was to present the plans for retreat center. The center will include Meditation classes. It will be located on the west side of Hacienda Boulevard consisting of 25 acres, the property is owned by the temple.

A group of professional Engineers, Architects, Developers and Consultants made a presentation which included visual boards, PowerPoint presentation. A miniature model of the projected plan was made available to the public for viewing. The plan includes hiking trails and the natural native plants and trees.

There were over 100 people in attendance and the proposed project received a welcoming review so far! There was representation from Supervisor Janice Hahn's office, her Field Deputy Nick Holden, State Senator Bob Archuleta was represented by Field Deputy, Kyle Miller. Also present was Andrea Gullo, Executive Director from Puente Hills Native Habitat Authority.

### Call 811 Before You Dig and Clean Power Alliance by Ted Chang-HHIA Board Director, Utilities

SoCalGas encourages customers to take the following steps when planning any digging project:

- Mark out your proposed work area in white (paint, chalk, flour, flags, etc.).
- Call 811 or submit an online location request to Underground Service Alert at least two working days prior to when you'll start digging.
- Wait to hear from SoCalGas they may come mark the natural gas lines, indicating pipe material and diameter, or let you know that the area is clear.
- Remember that SoCalGas' uses <u>yellow</u> paint to mark its lines.
- If you need to dig within 24 inches of a marked utility line, use only hand tools to carefully expose
   the exact locations of the line before using any power excavation equipment in the area.

Report any pipe damage – no matter how big or how small – by SoCalGas immediately at 1-800-

As of February 2019, Clean Power Alliance began serving all residential customers of unincorporated LA County. Non-residential customers in May 2019.

⇒ Why was I automatically enrolled as a Clean Power Alliance customer?

The 2002 State law that made community choice possible (AB 117), determined that the new local, public entities (in this case, Clean Power Alliance) would be the default energy provider and automatically enroll customers in the participating jurisdictions.

⇒ How do I know when my service begins?

All customers will receive a minimum of 4 notices by mail advising them of their enrollment in Clean Power Alliance; 2 before and 2 after the switch from Southern California Edison to Clean Power Alliance. These notices will be mailed by Clean Power Alliance, not by Southern California Edison.

#### Why It Matters

Hospitals. Fire departments. Schools. Even roads and highways. The census can shape many different aspects of your community. Each year, the results help determine how more than \$675 billion in federal funding is distributed to states and communities. It's also mandated by the Constitution: The U.S. has counted its population every 10 years since 1790.

By April 2020, households will receive an invitation to participate in the census. You'll then have three options to respond: online, by phone, or by mail. Event date for Census Day is April 1, 2020, with events across the country. This is a key date for the 2020 count: When completing the census, you'll note where you are living on **April 1.**
